**3.1. Travel information and the applied amount (Mandatory)**

The Mobility Funding grant covers maximum a ten days' stay in a Nordic or Baltic country. The grant sum is made up of two parts: a travel grant based on an average calculation in two categories (the capital region, the rest of the country) and accommodation/per diems based on the amount of journey days (max. 10). The two parts can either be applied for together or you can choose to apply separately for only one of the categories.

The amounts for travel grants and accommodation/per diems can be found on Nordic Culture Point's website [www.nordiskkulturkontakt.org](http://www.nordiskkulturkontakt.org). Both individuals and groups (max. 6 persons) are eligible to apply. All members in a group application should travel as one group from and to the same destination on the same dates. Please also note that you cannot apply for funding to travel to multiple destinations. The contact person in a group application has to be one of the travellers: a third party cannot apply for mobility funding on behalf of a group of travellers. Also note, that Nordic Culture Point does not support travels that have taken place before the expert group has made their decisions. The first possible travelling date is eight (8) weeks from the application deadline.
